

ACTIVE AMCHAM COMMITTEES & TASKFORCES

Law Making & Implementation Committee

The Committee has continued its goals to advocate for the inclusion of the business in the law-making processes and to ensure more effective implementation.

The analysis of the most important economic laws, the purpose of which was to assess the predictability and stability of the regulatory environment based on several parameters, has been reestablished in 2021 after a 5 years gap, providing a total of 17 years bases for analysis.

The Committee also scanned the practical application of the regulation and identified the possible difficulties that businesses could face in the procedures under the jurisdiction of the Central Registry. The findings of the analysis were presented to representatives of the Central Registry.

As third major focus the Committee undertook an activity to determine the possibility for holding virtual shareholder meeting by conducting an analysis of the regulatory environment and the technical opportunities that are necessary for predictability of the process.

As part of its broader goals, the Committee has advocated for highlighting the importance of the local economy and enhancing cooperation with the Government, other business organizations, and the international community regarding the proposed laws, programs, and strategic plans.

Digital Transformation

In its first year, the Committee has prioritized the promotion, development, and implementation of projects driving the digital transformation of the public sector, as well as initiatives for innovation-friendly regulation. Consequently, the primary focus of the Committee's efforts in 2021 has been to continue and support the goal of promoting the digital transformation of the public sector by participating and providing its expertise in working groups established by public institutions.

Through the organization of educational training and podcasts focusing on cyber security, the Committee also focused on promoting and creating initiatives to improve digital awareness in the society. Members of the Committee have collaborated on various projects, forming new business partnerships between company members.

ESTABLISHMENT OF NEW TASKFORCES:

Healthcare Taskforce

The recent period has shown how profoundly healthcare can influence the economy and society, and the need for building a resilient healthcare sector as an essential pillar for welfare of the whole society.

To our great delight, AmCham members who share the same determination toward creation of a modern, affordable, and efficient healthcare system contributed to the establishment of the Heathcare Taskforce, expanding our advocacy efforts.

Improving access to innovative medicines and medical devices and fostering innovation in the healthcare sector has been noted as an ultimate priority of the Task Force. By introducing itself as a reliable and constructive partner of the policymakers, the Task Force promotes digitalization and using data in the decision-making processes and co-creating a stable, transparent, and predictable regulatory affecting the healthcare sector.

Donation & Sponsorship Taskforce

The Donation & Sponsorship Taskforce was established as part of the Partnership4Giving Project by Association Konekt, in light of the announced changes in the local regulatory environment affecting the companies' decisions regarding their donation and sponsorship activities. The Taskforce is a member of the Ministry of Justice's working group responsible for drafting the new Donation and Sponsorship Law. The aim of the Taskforce is to advocate for and provide expertise in the consultation process toward creating a more efficient, facilitated and beneficial-for-all-stakeholders system for donations and sponsorships in our country.

INITIATIVES FOR ESTABLISHMENT OF NEW COMMITTEES & TASKFORCE:

ESG (Environmental, Social & Governance) Committee

Given ESG's prominence as a fresh and rapidly expanding concept on a global basis, numerous AmCham members launched an ESG Committee effort.

Taxation Taskforce

An initiative for establishing a Taxation Taskforce was taken in light of the announced tax changes and their effects on the local business sector.

TO EXPAND TRADE RELATIONS AND

Confirming the importance of bilateral cooperation between the neighboring countries, the Board of Directors representatives from the American-Hellenic Chamber of Commerce and AmCham North Macedonia used the meeting during the 5th Southeast Europe Energy Forum in Thessaloniki to wrap up the activities discussed during the past several months. During that time, two e-meetings between the Boards of both AmCham Offices were held in regard to deepening collaboration aimed to initiate joint projects and activities for the promotion of regional cooperation, expanding trade relations and increasing interconnectedness of the business community in the two countries.

The main objective of the visit in Thessaloniki was laying the foundations of the first joint trade mission and meeting with the U.S. Ambassador to North Macedonia, Kate Marie Byrnes and Deputy Chief of Mission in the US Embassy in Greece, David Burger. The meeting was attended by AmCham Greece BoD and Executive Office representatives, as well as BoD President Maja Filipceva, Vice-President Nikola Ljushev, Secretary Treasurer Dragan Davitkov and Executive Director Jelena Arsovska, representing AmCham North Macedonia.




Reducing Air Pollution in North Macedonia - Popularization and Enabling of E-Mobility, by EVN


